Grants are available for childcare facilities, but they would only fund the childcare section of a new building. The Town has contracted out a study assessing the efficiency and sustainability of their buildings. There are some grants to support spaces for Indigenous collections. It is possible to combine various types of grants for a project. The Town staff will send a list of potential grants to Christine. The 2018 plans for the library need to be updated to 2024 standards, which will cost money, but we can apply for grants. The Board will form a new Building Committee.
